## Main Purpose of the Role

This team member will also serve as program manager to our Diversity, Equity, and Inclusion (DEI) program, supporting our DEI Committee. The successful candidate will assist in development of the firm's social impact strategy, roadmaps and goals as part of our ESG+R commitment. To bring that strategy to life, this team member will also be responsible for leading and supporting projects that drive the implementation and communication of the firm's social and societal impact.
